The Ninth School, which continues the series of eight schools organized by the Institute of Mathematics of the Academy of Sciences of the Czech Republic in 1978, 1982, 1986, 1990, 1994, 1998, 2002 and 2006, will take place at Conference Centre of the Academy of Sciences Třešť from Saturday, September 11 (the day of arrival), to Friday, September 17, 2010. 2. Conference site

The school will take place at the hotel in the castle Třešť. Třešť is situated in in the heart of the Czech-Moravian Highlands, around 150 km from Prague. A conference bus from Prague will be organized on September 11 and also on the way back on September 17. The room and board is arranged for all participants in the hotel.

3. Conference fee

The conference fee for a regular participant is EUR 250. A reduced rate of EUR 200 will be offered provided that the payment is made before April 30, 2010. The conference fee for accompanying persons is EUR 50.

The conference fee includes transportation between Prague and Třešť, scientific and social programme (including excursion), one copy of abstracts of invited lectures and one copy of proceedings of the invited talks at the school.

4. Board and lodging

Local expenses (room and board) will be paid directly at Třešť. We estimate its value at EUR 220-250 depending on the exchange rate and next year's prices. We will put detailed information at the web page of the conference at the beginning of the year 2010.
